

Registration Skitilla 2020

The ski trip 2019 will take place from 14-02-2020 up to and including 23-02-2020. This means there will be eight days, in which it is possible to go skiing/snowboarding. The ski pass included in the price is only for six days, however there is an option to buy up to two more days. The sign up closes on 16-10-2019. The skitrip will go to Gerlos, ski area Zillertal

ARTICLE 1. COSTS

Estimated costs of the trip are €818,00 and the maximal costs are €872,69. This is without renting gear and/or lessons. Extra costs for gear, lessons and an extended ski pass are for the attendee and can be found on the last page of this contract.

1. The costs can be split into 6 parts:
 - a. Accommodation, tourist tax, bus-trip and ski pass
 - i. Estimated costs: € 716,75
 - ii. Maximum costs: € 727,38
 - b. Food and small miscellaneous costs
 - i. Estimated costs: € 60,00
 - ii. Maximum costs: € 80,00
 - c. Cost for the car (Car will be used for transport of food from the Netherlands)
 - i. Estimated costs: € 26,00
 - ii. Maximum costs: € 42,00
 - d. Unexpected costs
 - i. Estimated costs: € 12,50
 - ii. Maximum costs: € 20,00
 - e. Other costs (rental gear, lessons, beer, etc.)

These costs are attendee specific, a full ski/snowboarding set (shoes, skis/board and ski poles) costs around €120 per week, (see last page)

2. Costs for accommodation, bus, ski pass and the material need to be paid via the website of totally. The remaining costs (car, food and other minor things) will be billed after the trip by Scintilla.

ARTICLE 2. CANCELLATION OF THE TRIP

1. The Ski trip will be cancelled if the costs for the participant will be more than the in article 1 specified maximum costs and therefore Skitilla will carry more risk than €750 as specified at the GMA of 11-04-2018.
2. At the moment of booking (Wednesday the 16th of October 2019) there is a maximum of people that is possible to book for, because there is no room for everyone or because the costs will surpass the set budget, there is a possibility that you are excluded from the trip. This will be decided by Skitilla looking at the time of signing the contract. There is no arguing the decision of Skitilla. If the participant is excluded there will be no costs for the participant.
3. In case the trip is cancelled there will be no costs for the participant.

ARTICLE 3. TRAVEL DOCUMENTS

1. The participant is responsible for his own travel documents that are needed to take part in the trip. SKItilla does not accept any liability in this regard.
2. If the participant can not take part in the trip because travel documents are lacking, the participant does not have the rights for a refund or cancellation of any fees.

ARTIKEL 4. EXPECTED BEHAVIOUR

1. Skitilla is before, during and after the ski trip not liable for the behavior of the participant and the possible consequences of his behavior. Skitilla accepts no liability for possible extra costs, following misbehavior of the participant.
2. The participant is obligated to wear a helmet at all times during skiing, snowboarding or any other activities which could lead to physical injuries. In the case a participant does not obey this, the participant can be secluded by Skitilla from the entire or rest of the skiing trip. All costs resulting from this, are to be paid by the participant.

ARTIKEL 5. CANCELLATION

1. The participant has no right to cancel and/or refund, unless Skitilla decides otherwise. For example when someone else takes their place.

ARTIKEL 6. EXONERATION

1. Skitilla is in no way responsible for any damage caused by or done to the participant and/or third parties.
2. The participant will not invoke force majeure, in particular, but not exclusively, based on arguments relating to study reasons and financial situation.
3. Participants who cause nuisance or inconvenience in such a way that a proper course of the ski trip is thereby made more difficult in Skitilla's opinion can be excluded by Skitilla from the entire ski trip or continuation of the ski trip. All costs ensuing from this will be payed for by or charged to the participant in question .

ARTIKEL 7. PRIVACY

1. In case of any emergency, Skitilla collects data from participants and emergency contact persons. This data contains telephone numbers and e-mail addresses. This data will be stores at Scintilla, in accordance with the data processing agreement, until a month after the official completion of Skitilla.

ARTIKEL 8. FINAL PROVISION

The board of E.T.S.V. Scintilla decides on all matters not covered by this agreement.
